Introduction

Shrewsbury International School Phnom Penh recognises the importance of Relationships and Sex Education (RSE) as a vital part of a pupil's personal, social, and health education (PSHCE). This policy outlines the school's approach to delivering a comprehensive and age-appropriate RSE programme for all pupils.

- Sex and sexuality: Human anatomy and reproduction, sexual orientation, and healthy sexual relationships.
- Sexual health: Sexually transmitted infections (STIs), contraception, and staying safe online.

The RSE programme will be delivered through a variety of methods, including:

- Classroom lessons
- Group discussions
- Guest speakers
- Workshops

Partnership with Parents

The school acknowledges parents' primary role in the RSE of their children. We are committed to working in partnership with parents to ensure a consistent approach to these sensitive topics. Parents will be informed about the RSE programme content and will have the opportunity to discuss any concerns they may have.

Right to Withdraw

Parents have the right to withdraw their child from all or part of the non-compulsory elements of the RSE programme. However, the school strongly encourages parents to discuss any concerns with the school leadership before making a decision.

Staff Training

All staff involved in delivering the RSE programme will receive appropriate training to ensure they feel confident and competent in addressing these sensitive topics.

Monitoring and Evaluation

The RSE programme will be regularly reviewed and evaluated to ensure its effectiveness and to reflect the changing needs of the pupils.

Resources

The school will provide a range of resources to support the RSE programme, including age-appropriate materials and websites.
